# PRIVACY POLICY OF ENERGINET REGARDING MARKET CONSULTATION FOR HYDROGEN INFRASTRUCTURE

In regards of processing personal data Energinet is defined as the “Data Controller”. We process these data with the outmost care and constantly make sure that we are compliant with the laws regarding dataprotection.

In this privacy policy we describe how we process your personal data and what rights you as a “Data Subject” have under the law.

## We are collecting these personal data regarding you

Energinet is collecting the following personal data:

## Purpose of processing personal data

Energinet is processing your personal data to fulfill the following purposes:

- To take contact for clarification questions regarding your response to the market dialogue

## Legal basis for the processing of personal data

Energinet is solely processing your personal data to the extent it is necessary in regards to the relation you have with us or according to the law.

The legal basis for our processing of personal data:

- Registration of personal data required by law is done pursuant to Databeskyttelsesloven section 6, subsection 1 cf. the General Data Protection Regulation section 6, subsection 1, paragraph a, which is necessary for the possibility to revert to the respondents for clarification purposes.

## Erasure

We will erase or anonymize any personal data on you by the end of January 2022.

## Disclosure of personal data

Energinet is disclosing personal data in the following cases:

- For crime solving purposes pursuant to Danish law and under strict observation of the rules of data protection.
- Your personal data may be subject to any access to documents in accordance with the rules of the Public Administration Act, whereby personal information about you may be disclosed to another party.
- Your information may also be disclosed to Energinet's group companies when there is a legitimate interest in disclosing personal information for internal purposes. Special Energinet Elsystemansvar A/S, who is responsible for handling the assignment.

In each individual case, we will assess whether the disclosure requires your express consent, or whether the disclosure can take place on a different legal basis.

## Your rights

You have a number of rights under the law in relation to our processing of personal data about you. You can make use of your personal data rights by contacting us. You will find our contact information at the top of this Privacy Policy.

Once you have requested access to the personal data we have registered about you, to have it corrected or deleted, or if you have objected to our data processing, we will investigate whether it is possible to accommodate your request. We will respond to your inquiry as soon as possible and no later than one month after we have received your inquiry.

Your rights:

- Right of access  
You have the right to access the personal data we process about you.
- Right to rectification  
If you believe that the personal data we process about you is inaccurate, you have the right to have it corrected. You must contact us and inform us of the inaccuracies.
- Right to erasure / "right to be forgotten"  
We delete personal data when it is no longer necessary to store them. In special cases, you have the right to have specific information about you deleted before the time of our regular deletion occurs. If you believe that your data is no longer necessary for the purpose for which we collected it, you may request that it be deleted.
- Right to restriction of processing

If you do not agree with the information we have recorded or otherwise process, you may ask us to limit the processing of the information until we have been able to determine whether the information is correct. You can also request restriction instead of deletion if you believe our processing of the information is illegal, or if you believe we no longer need the information, or if you believe that your legitimate interests take precedence over Energinet's legitimate interests as data controller.

➤ Right to data portability

In certain cases, you have the right to receive your personal data and the right to request that the personal data be transferred from one data controller to another.

➤ Right to object

You have the right to object to our processing of information about you. If your objection is justified, we will make sure to stop processing the information.

➤ Right to complain

If you are not satisfied with our answer, you can complain to the Danish Data Protection Agency. In general, if you are dissatisfied with the way in which your personal data has been processed, you can complain to the Danish Data Protection Agency, which will then investigate the case and make a decision.
