Energinet presented the status of the Baltic Pipe project along with the implementation of the new balancing model up until go live on the 1st of October. Additionally, accumulated questions from the previous Q&A relating to the new balancing model and smoothing specifically were presented and answered.

General questions and comments

- Shipper: Will we get the data for testing by the 1st of September or is there a hard deadline for when we can expect them?
 - Energinet: We will send the data for testing ASAP and if you
 have not received it before, by the 1st of September we will announce a deadline for when you will receive it.
- Shipper: Is it possible to receive sample data before the testing period, in case it is the flow-data that is not yet available?
 - o Energinet: We will get back to you on that.

- Shipper: In case of an emergency where non-protected customers are excluded, will the S-max calculations be revised as to showcase the difference in offtake both during exclusion and after reimplementation of non-protected customers?
 - Energinet: Our expectation is that this should not affect the Smax calculation, as we would still expect a similar offtake profile, but at lower consumption level. We will however consider if it may have any impact.
- Shipper: Regarding the change in balancing prices in the case of an emergency, will we be notified of the changes in advance?
 - Energinet: As far as it is possible there will be a lead time to the changed balancing prices. However, in certain sudden situations it might not be possible.
- Shipper: question about standard encryption
 - Energinet: AS4 connection test with partner. Nomination test as of start September.
- Shipper: question about certificates
 - Energinet: Our external partner, Virtimo, is responsible for the certificates. Contact person: Henrik Kjølle (hkj@energinet.dk)
- Shipper: Where can I find a list of the tests and types of messages needed?
 - o Energinet: Updated documentation regarding the new balancing model is available here:

- Shipper: question about smoothing communication
 - Energinet: Not a standard Edigas message, so it is being developed. Will be in XML format, however, not fully finalized yet.
 Will be ready for testing in September.
- Shipper: Where will it be possible to see balancing prices when they are for every hour?
 - Energinet: Prices based on yellow zone trades will be published in the green zone view on our website. Cash-out prices will be published via EDS and can retrieved via an API.

- Shipper: How will shippers be notified in case of a mismatch on interconnection points
 - o Energinet: Shippers will be notified via a nom res.
- Shipper: Is it necessary to nominate consumption in Sweden?
 - o Energinet: To be sure it is necessary to ask Nordion directly
